



Webinars on Community Forests in California – April 2011



The Northern California Society of American Foresters and the University of California Cooperative Extension in collaboration with our partners is offering a webinar and field trips on the topic of **community forests and community forestry**.

Community forests are forested lands that are managed to produce goods and services of importance to people living within the forest or otherwise dependent upon them for economic, environmental, recreational or spiritual values. The objective of this webinar is to present an overview of community forestry as it is currently being practiced in California. The intended audience for the webinar is natural resource managers, environmental and forest activist groups, residents of forested regions who might benefit from a community forest approach in their areas and the general public concerned with forest management.

How the Webinar Works

People who wish to view the webinar presentations will be provided with an internet address. At the date and time of each webinar presentation, they will log in to view them. After formal presentations, viewers will be given the opportunity to text questions to presenters for discussion.
