I. LEASE TERM

II. ASSIGNMENT OF LEASE

LESSEE shall not have the right to sub-lease said horse.

III. LEASE PRICE

IV. CARE OF THE HORSE

LESSEE hereby agrees to keep said horse in good health, giving due consideration to upkeep of
shots, wormings, hoof care, and individual needs of said horse and to pay _____
expenses associated with such care. LESSEE shall maintain humane treatment and regular exercise.
Failure on the part of the LESSEE to perform any of the above horse care shall result in LESSOR'S
immediate possession of said horse. The LESSEE further agrees to stable horse at

V. LIABILITY

LESSEE shall have care, custody and control of said horse during the lease period. LESSEE agrees to be responsible for and hold LESSOR harmless from all claims, demands, causes of action, judgments, attorney's fees, costs and expenses for property damage, bodily injury, or death caused by or connected with said horse while in LESSEE'S care, custody and control. LESSEE will carry liability insurance which would cover the actions of said horse for the entire duration of the lease. As of this agreement date, LESSEE agrees to total responsibility.

- A. Have all waivers for 4-H and 4-H insurance up-to-date.
- B. Abide by the 4-H helmet regulation set forth by the 4-H Program.
- C. Abide by all 4-H County 4-H horse agreements or rules set forth.

VI. REMEDIES ON BREACH/ELECTION TO TERMINATE

If said agreement needs to be terminated, then a _____ Day Notice is to be given by either the LESSOR or the LESSEE.

If LESSEE'S performance of covenants and conditions set forth herein are not met, then LESSOR can declare the lease agreement forfeited.

VII. REPRESENTATIONS

LESSOR represents that said horse is in sound health and that there are no known illnesses, infirmities or unsoundness'. LESSOR further represents that said horse currently has no history of vice, or dangerous habit which would be uncharacteristic of the nature of the animal known as the horse.
