# **COVID-19 Updates**

#### Occupancy Limits for UC 4-H Activities and Programs

- √When meeting in-person, limit occupancy based on the Occupancy Limit table below.
- √The county's status is posted on the state California's Blueprint for a Safer Economy.
- √ This status is updated every Tuesday.
- √The county status must be checked 7 days before an in-person meeting for any changes.
- ✓ Ensure the facility will allow for physical distancing with 36 square feet per person.
- ✓ If there is not enough space for 36 square feet per person, the project leader must reduce the number of people or identify a different facility.



County Tier Status	Indoor	Outdoor
Widespread (Purple)	NO indoor in-person meetings, events or activities.	Maximum 10 persons  Maintain 6ft of distance
Substantial (Red)	Capacity = Area of Room/ 36sq ft per person Or maximum 25% of room capacity, whichever is lower. No more than 100 people	Maximum 100 people  Maintain 6ft distance between all participants during activity
Moderate (Orange)	Capacity = Areas of room / 36 sq ft per person  Or maximum 50% of room capacity, whichever is lower.  No more than 200 people	Maximum 200 people  Maintain 6 ft distance between all participants during activity
Minimal (Yellow)	Capacity = Area of Room / 36 sq ft per person Or maximum 50% of room capacity, whichever is lower	Maximum 50% of space  Maintain 6 ft distance between all participants during activity





## Trinity County Fair Market Project Participation Larry Forero, Livestock Farm Advisor


Now that the details associated with the 2020 Trinity County Fair are wrapping up I started to reflect on the number of youth positively impacted by the fair through the market animal program as compared to the number of youth enrolled locally in 4-H. In 2020 68 youth exhibited and sold livestock at Trinity County Fair. The total number of lots has experienced a downward trend this year as a direct result of COVID-19. Many participants chose to not participate in the market classes this year. Figure A outlines the total number of lots sold at the fair between 2006 and 2020.



Youth can participate in this program as 4-H, FFA, Grange or Independent exhibitors. Determining the number of exhibitors is a little challenging in that participants can sell two animals. Exhibitors were only counted once regardless of number of lots sold annually. The number of exhibitors has trended down. Figure B outlines the number of exhibitors locally.



It is interesting to look at the importance of market animal projects. In the 2019/20 there were 86 youth participating in 4-H in Trinity County. Of these 18 are primary members (recall they cannot participate in market animal projects per policy). About 82% of the 68 members that can participated in animal projects chose to do so. It is interesting to note that this year only 37 of the 56 youth enrolled in market animal projects chose to exhibit and sell at the 2020 Trinity Co. Fair. The 18% that did not participate in market animal projects participate in projects ranging from photography and quilting to shooting sports. Figure C shows the percent of total enrollment of youth choosing to participate in market animal projects. The general trend is up.



This underscores that market animal projects are an important component of the 4-H program locally and are a valuable youth engagement opportunity. As population and demographics in the county change we need to understand the educational needs of local youth and look for opportunities to address these needs.

# Why have a 4-H Record Book?

Completing the Personal Development Report in the Record Book provides you an incentive for participation, learning, and achievement.

What do I include in my Personal Development Report (PDR) and where do I record these events and activities?

- Record your participation and activities in and outside of 4-H for the current program year (July 2020-June 30,2021).
- When you attend a 4-H evet, record it as a 4-H event.
- When you do something at the event that meets the requirement of another category, you can record that as well. Although, some events and activities may be applicable for multiple categories you can only count that activity in one category. Record the activity needed for your star ranking.
- You may record up to two significant activities outside of 4-H in categories 2,4,5,6, and 7.

Category 1— Projects Completed	Example: Sewing, Market Swine, Foods
Category 2—Project Skills Completed	Must demonstrate your knowledge to an audience/judge.
Category 3—Events Attended	Actively Participate in the 4-H event. Example: Favorite Foods Day
Category 4—Leadership Development	Example: Leadership role, led an activity , Served on Committee
Category 5—Citizenship & Community Service	Community service activity, Service Learning, or Civic Engagement
Category 6—Communication Skills	Example: Presentation, Letters about 4-H, submit and article
Category 7—Honors & Recognitions	Example: Star Rank, Event Medalist, or Best in Show.
Category 8—Healthy Lifestyles	Activity outside of 4-H with a minimum of 25 hours. Example: Sports, Bank, or employment.
