Kayla Tofte is the new Community Education Specialist for Placer County 4-H. Kayla recently graduated from Chico State with a Bachelor's of Science Degree in Agriculture Education. She specialized her degree towards animal science courses. During her childhood, Kayla was an active member of Chicago Park 4-H in Nevada County. She had multiple roles on officer teams and as a junior and teen leader in the Chicago Park 4-H Beef Project and Countywide Horse Project. She later joined FFA, where she competed on Parliamentary Procedure and Veterinary Science teams. After high school, she attended Feather River College in Quincy, CA to go to school on a smaller campus and to bring her horse to school with her. Taking classes on her horse was one of her favorite experiences in school. She is currently an Assistant Leader for the Nevada County 4-H horse project and the leader for the Chicago Park Dairy Cattle Project group. Her biggest goal as a community education specialist is to find more ways for kids to get involved outside of just club events and to get them engaged in the planning of events and in committees. .

It is with great sadness that we inform you of the loss of our dear friend Lee Bastien. Lee has played an important role in shaping the Placer County 4-H club over the years. He has been a leader in Placer County since 1999. Lee was the Sheridan 4-H rabbit, poultry, and cavy leader. He was the countywide coordinator for the poultry and rabbit groups and took on various roles in the 4-H council. You could always find Lee on the BBQ at coordinator events.

Lee was always the first one at events and the last to leave. He was known to always be opening and closing the Small Animal Barn at fair and helping with judging, sometimes until 11PM. He was always there to encourage 4H members and adults with his calm and fair demeanor. Nothing could keep Lee from being there for the kids, even in his last years and 110-degree weather. His mentorship went well-beyond his project groups. He was a guest speaker at many other club project meetings and loved to put smiles on the kid's faces.

One story of Lee was, when he was determining chick breeds, he came across a mixed chick, and it brought smiles to everyone's faces, when while holding the chick, and with a contagious laugh, he proclaimed "I have no idea what this one is!"

Lee always looked out for the kid's best interest and supported them in any way he could. He did this both in and outside of the 4-H community. He participated in rabbit judging at the Yuba County Fair and was the bookkeeper at his church in Wheatland. His love for others was not limited to people. He was known to take in animals needing rehoming.

Lee was a huge inspiration for various members in various ways: from competing at fair to becoming an all-star or county ambassador. He was a like a father figure to many who crossed his path in 4-H. He inspired many youth to become leaders. He will be deeply missed, but his legacy will live on in all the youth he has influenced.

COVID-19 UPDATES ~ 2/7/2022

Update to in-person activities, effective Feb. 15, 2022

Both indoor and outdoor in-person activities are resuming, in line with the Basic Safety Standards, updated 2/15/2022.

Protocols for Outdoor Activities

- Face masks are not required when social distancing of 3 feet is maintained.
- If social distancing is not possible, masks are required.

~~Maximum number of participants at outdoor gatherings sponsored/hosted by UC 4-H must be under 5,000 people. For events with more than 5,000 participants, please follow the state guidelines for mega-events~~

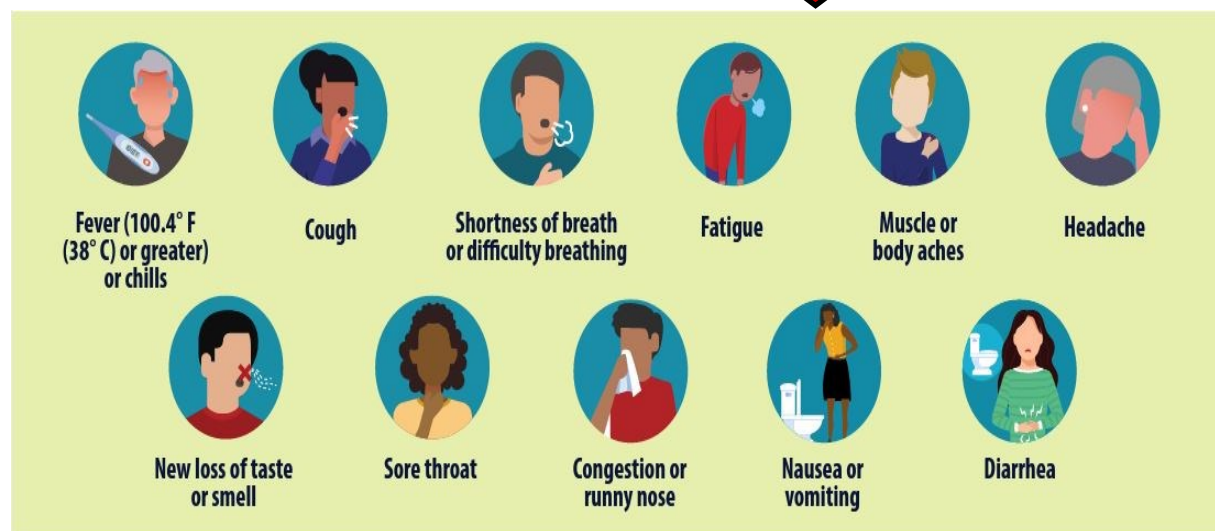
Protocols for Indoor Activities

- When youth and adults are present: **Masks are required for all persons, regardless of vaccination status.**
- When only adults are present: Those who are fully vaccinated are not required to wear masks.
- Maintain social distancing of 3 feet

To find out if your County has a specific mask order or other public health guidance that is different from the state, review [your local public health COVID website](#).

Do not participate in any in-person 4-H activities if you are sick or have COVID-19 symptoms or if you or someone you have been in contact with has been diagnosed with COVID-19.

DON'T FORGET TO COMPLETE FUNDRAISER FORMS

Fundraiser Forms (CA 4-H Treasurers Manual Form 8.7) for Council, Club, and Project fundraisers must be completed and turned in at the UCCE Office for approval at least **two weeks prior** to your event, to ensure we are following State 4-H policy and are able to receive approval from our County Director.

Please be sure all sections are completed properly and all signatures are obtained.

ENROLLMENT REMINDER:

Project Leaders **may not work with youth** until they are confirmed and made “Active” in 4hOnline, for the current program year.

*An adult enrollment is made “Active” for the current year when ALL enrollment steps are completed:

1. re-enroll in [4hOnline](#)
2. complete mandatory online trainings,
3. pay yearly enrollment fee.

The County Director reviews and approves 4-H volunteer appointments after all the application requirements and mandatory online trainings are completed. If you have any questions about this process, please contact your 4-H office as soon as possible.

2021-2022 California Returning Volunteer Course

Reporting Child Abuse and Neglect Course (only required for returning volunteers who did not complete the 2020-2021 Volunteer course and received a Covid-19 exception from their county)

PROJECTS, CLUB MEETINGS, or EVENTS

A **Facility Use Request form (FUR) MUST** be submitted by the Club/Project Leader **PRIOR** to the beginning of a project, meeting, or event.

* Allow 14 days to process requests. New facilities may take longer *

To prepare for a 4-H presentation, youth learn how to:

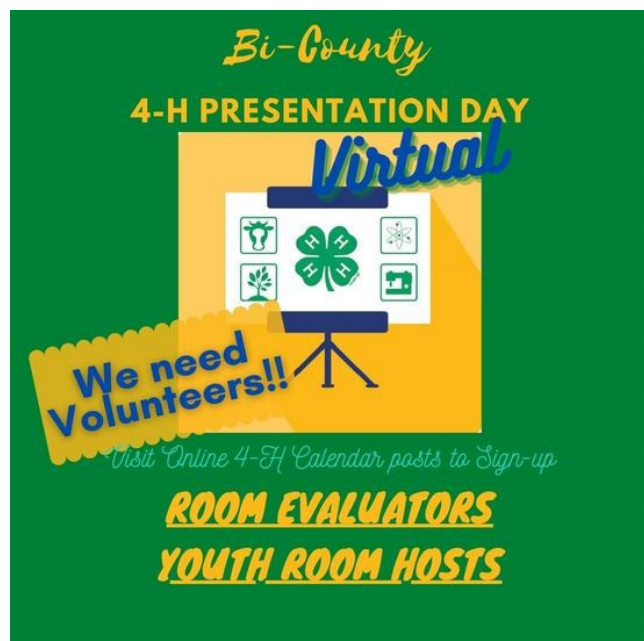
- Research a subject
