



## AMADOR COUNTY 4-H MANAGEMENT BOARD 4-H SCHOLARSHIP APPLICATION



### OBJECTIVE

To recognize and financially assist 4-H members who have demonstrated the highest of achievements in active 4-H leadership within the county. Members must indicate their willingness to contribute time to the 4-H program as adults.

### GUIDELINES

- 1) The 4-H Scholarship will be awarded to graduating seniors and/or those who have previously graduated, who are active 4-H members. They must have made outstanding contributions to 4-H during their academic years, have a desire to continue working in 4-H, and have high scholarship achievement.
- 2) Recipients must have lived in Amador County for at least two (2) years, be currently enrolled in 4-H, and have achieved Gold Star rank or equivalent to apply for the scholarship.
- 3) Award amount is \$1000.00 to the recipient. A 4-H member can receive the Scholarship only once.
- 4) Recipients must attend an accredited institution of post-secondary education or training in the United States in a program that has a duration of at least three quarter terms or two semester terms.
- 5) Financial Management Chair will issue a check to the recipient(s) when notification of enrollment is received from the institution. Failure to enroll within one year voids the award and the amount shall remain with the Amador Volunteer Management Board.
- 6) The selection committee will be composed of three leaders, each having three years experience as a project leader and each from different clubs. None of the three may be related to the applicant. Consideration shall also be made to minimize the possibility of a judge and applicant having the same 4-H club affiliation.
